MONTHLY INFORMATION

on the performance of the NBS RTGS system, clearing system, and interbank and international clearing of foreign exchange payments in January

In the course of 19 business days in January, a total of 16.6 million payments were processed in the NBS RTGS (13.7 million or 82.5%) and clearing systems (2.9 million or 17.5%). The average number of payments was 874,792 per day, of which 721,434 in RTGS and 153,357 in clearing.

The value of turnover in the RTGS system amounted to RSD 7,589.5 billion, while clearing turnover reached RSD 35.8 billion, or 0.5% of the total.

Daily turnover in the RTGS and clearing systems averaged RSD 399.4 billion and RSD 1.9 billion, respectively.

As there was a 25-minute downtime during 10,725 minutes of production, the availability of the NBS RTGS and clearing systems was 99.8%.
