MONTHLY INFORMATION

on the performance of the NBS RTGS system, clearing system, and interbank and international clearing of foreign exchange payments in January 2024

In the course of 21 business days in January 2024, a total of 17.8 million payments were processed in the NBS RTGS (16.5 million or 92.9%) and clearing systems (1.3 million or 7.1%). The average number of payments was 847,271 per day, of which 787,514 in RTGS and 59,757 in clearing.

The value of turnover in the RTGS system amounted to RSD 19,573.3 billion, while clearing turnover reached RSD 27.7 billion, or 0.1% of the total.

Daily turnover in the RTGS and clearing systems averaged RSD 932.1 billion and RSD 1.3 billion, respectively.

There was no downtime during 11,745 minutes of production of the NBS RTGS and clearing systems and the system availability was 100.0%.
