**MONTHLY INFORMATION**  
**of the NBS RTGS system, clearing system, and interbank and international clearing of foreign exchange payments in March 2023**

In the course of 23 business days in March 2023, a total of 20.8 million payments were processed in the NBS RTGS (18.7 million or 90.0%) and clearing systems (2.1 million or 10.0%). The average number of payments was 902,566 per day, of which 812,567 in RTGS and 89,999 in clearing.

The value of turnover in the RTGS system amounted to RSD 17,549.9 billion, while clearing turnover reached RSD 39.3 billion, or 0.2% of the total.

Daily turnover in the RTGS and clearing systems averaged RSD 763.0 billion and RSD 1.7 billion, respectively.

As there was no downtime during 12,765 minutes of production, the availability of the NBS RTGS and clearing systems was 100.0%.
