MONTHLY INFORMATION
on the performance of the NBS RTGS system, clearing system, and interbank and international clearing of foreign exchange payments in April 2025

In the course of 20 business days in April 2025, a total of 19.0 million payments were processed in the NBS RTGS (18.1 million or 95.0%) and clearing systems (0.9 million or 5.0%). The average number of payments was 951,366 per day, of which 903,960 in RTGS and 47,406 in clearing.

The value of turnover in the RTGS system amounted to RSD 17,288.4 billion, while clearing turnover reached RSD 24.6 billion, or 0.1% of the total.

Daily turnover in the RTGS and clearing systems averaged RSD 864.4 billion and RSD 1.2 billion, respectively.

There was no downtime during 11,100 minutes of production of the NBS RTGS and clearing systems and the system availability was 100.0%.
