## **Information**

on NBS RTGS and clearing system turnover and interbank clearing of foreign exchange payments in May 2010

In the course of 20 business days in May 2011, a total of 17.5 million payments were processed in the NBS RTGS (11.3 million or 64.5%) and clearing system (6.2 million or 35.5%).

The average number of payments was 874,989 per day, of which 564,401 in RTGS and 310,588 in clearing.

The value of turnover in the RTGS system amounted to RSD 2,615 billion, while clearing turnover reached RSD 41.8 billion or 1.6% of the total.

Daily turnover in the RTGS and clearing system averaged RSD 130.7 billion and RSD 2.1 billion respectively.

A total of 3,261 payments worth EUR 26,743,094.98 were processed in the interbank clearing of foreign exchange payments, with 24 participants\*. The system worked smoothly throughout the period under review.

As there was no downtime during 10,800 minutes of production, the availability of the NBS RTGS and clearing system was 100%.
