NBS RTGS and Clearing System Turnover in June 2006

In the course of 22 business days of June 2006, a total of 13.09 million interbank orders worth CSD 1,342.37 billion were processed. Of that number, clearing orders accounted for CSD 64.96 billion or 4.84%. Average daily turnover amounted to CSD 61.02 billion, while the average number of payments reached 595,076 – whereof 262,817 were RTGS payments and 332,259 clearing ones.

The monthly value of interbank payment turnover reached in June the highest level ever - CSD 1,342.37 billion. June also saw the highest daily average of the NBS RTGS and clearing system turnover of CSD 61.02 billion.

Out of total 13.09 million interbank payments processed in the previous month, 7.31 million or 55.83% were clearing orders, and 5.78 million or 44.17% were RTGS orders. The daily clearing payment average value equaled CSD 2.95 billion.
