Information

on NBS RTGS and clearing system turnover and interbank clearing of foreign exchange payments in June 2011

In the course of 22 business days in June 2011, a total of 18 million payments were processed in the NBS RTGS (11.8 million or 65.68%) and clearing system (6.2 million or 34.32%).

The average number of payments was 818,715 per day, of which 537,723 in RTGS and 280,992 in clearing.

The value of turnover in the RTGS system amounted to RSD 3,061 billion, while clearing turnover reached RSD 42.8 billion or 1.4% of the total.

Daily turnover in the RTGS and clearing system averaged RSD 139.1 billion and RSD 1.9 billion respectively.

A total of 3,321 payments worth EUR 24,844,750.54 were processed in the interbank clearing of foreign exchange payments, with 24 participants*. The system worked smoothly throughout the period under review.

As there was no downtime during 10,940 minutes of production, the availability of the NBS RTGS and clearing system was 100%.
