NBS RTGS and Clearing System Turnover in July 2006

In the course of 21 business days in July 2006, a total of 12.3 million interbank orders worth CSD 1,315.76 billion were processed in the NBS RTGS and clearing system. Of that number, clearing orders accounted for CSD 64.06 billion or 4.87%. The average daily turnover value equaled CSD 62.66 billion. The average daily number of payments was 585,847, of which 261,978 were RTGS payments and 323,869 clearing payments.

On 7 July daily turnover hit record-breaking value of CSD 92.71 billion. July also saw the highest daily average turnover value of CSD 62.66 billion.

Out of total of 12.3 million interbank orders processed in the previous month, 6.8 million or 55.28% were clearing payment orders and 5.5 million or 44.72% RTGS payments. The daily clearing payment average equaled CSD 3.05 billion.
