MONTHLY INFORMATION

on the performance of the NBS RTGS system, clearing system, and interbank and international clearing of foreign exchange payments in July 2022

In the course of 21 business days in July 2022, a total of 19.4 million payments were processed in the NBS RTGS (17.0 million or 87.7%) and clearing systems (2.4 million or 12.3%). The average number of payments was 923,486 per day, of which 809,927 in RTGS and 113,559 in clearing.

The value of turnover in the RTGS system amounted to RSD 6,282.4 billion, while clearing turnover reached RSD 39.8 billion, or 0.6% of the total.

Daily turnover in the RTGS and clearing systems averaged RSD 299.2 billion and RSD 1.9 billion, respectively.

As there was no downtime during 12,375 minutes of production, the availability of the NBS RTGS and clearing systems was 100.0%.
