## MONTHLY INFORMATION

on the performance of the NBS RTGS system, clearing system, and interbank and international clearing of foreign exchange payments in July 2024

In the course of 23 business days in July 2024, a total of 19.9 million payments were processed in the NBS RTGS (18.4 million or 92.5%) and clearing systems (1.5 million or 7.5%). The average number of payments was 865,627 per day, of which 801,075 in RTGS and 64,552 in clearing.

The value of turnover in the RTGS system amounted to RSD 20,989.2 billion, while clearing turnover reached RSD 37.0 billion, or 0.2% of the total.

Daily turnover in the RTGS and clearing systems averaged RSD 912.6 billion and RSD 1.6 billion, respectively.

There was no downtime during 12,810 minutes of production of the NBS RTGS and clearing systems and the system availability was 100.0%.
