MONTHLY INFORMATION

on NBS RTGS and clearing system turnover and interbank and international clearing of foreign exchange payments in August

In the course of 22 business days in August 2013, a total of 16.0 million payments were processed in the NBS RTGS (11.5 million or 71.9%) and clearing system (4.5 million or 28.1%).

The average number of payments was 726,849 per day, of which 522,531 in the RTGS, and 204,319 in clearing. The value of turnover in the RTGS system amounted to RSD 4,542.7 billion, while clearing turnover reached 37.3 billion, or 0.8% of the total.

Daily turnover in the RTGS and clearing system averaged RSD 206.5 billion and RSD 1.7 billion respectively. As there was no downtime during 11,880 minutes of production, the availability of the NBS RTGS and clearing system was 100%.
