MONTHLY INFORMATION

on NBS RTGS and clearing system turnover and interbank and international clearing of foreign exchange payments in August 2016

In the course of 23 business days in August 2016, a total of 16.9 million payments were processed in the NBS RTGS (12.1 million or 71.2%) and clearing system (4.9 million or 28.8%). The average number of payments was 735,965 per day, of which 523,925 in RTGS and 212,040 in clearing.

The value of turnover in the RTGS system amounted to RSD 3,850.9 billion, while clearing turnover reached RSD 37.2 billion or 1.0% of the total.

Daily turnover in the RTGS and clearing system averaged RSD 167.4 billion and RSD 1.6 billion, respectively.

As there was no downtime during 12,825 minutes of production, the availability of the NBS RTGS and clearing system was 100%.
