MONTHLY INFORMATION

NBS RTGS and clearing system turnover and interbank and international clearing of foreign exchange payments in August

In the course of 23 business days in August 2018, a total of 18.9 million payments were processed in the NBS RTGS (15.0 million or 79.2%) and clearing system (3.9 million or 20.8%). The average number of payments was 823,421 per day, of which 652,383 in RTGS and 171,039 in clearing.

The value of turnover in the RTGS system amounted to RSD 4,370.6 billion, while clearing turnover reached RSD 34.3 billion, or 0.8% of the total.

Daily turnover in the RTGS and clearing system averaged RSD 190.0 billion and RSD 1.5 billion, respectively.

As there was no downtime during 12,855 minutes of production, the availability of the NBS RTGS and clearing system was 100%.
