MONTHLY INFORMATION

on the performance of the NBS RTGS system, clearing system and interbank and international clearing of foreign exchange payments in August 2025

In the course of 21 business days in August 2025, a total of 18.1 million payments were processed in the NBS RTGS (17.2 million or 94.8%) and clearing systems (0.9 million or 5.2%). The average number of payments was 863,957 per day, of which 819,047 in RTGS and 44,910 in clearing.

The value of turnover in the RTGS system amounted to RSD 17,652.8 billion, while clearing turnover reached RSD 23.4 billion, or 0.1% of the total.

Daily turnover in the RTGS and clearing systems averaged RSD 840.6 billion and RSD 1.1 billion, respectively.

There was no downtime during 11,655 minutes of production of the NBS RTGS and clearing systems and the system availability was 100.0%.
