MONTHLY INFORMATION

on the performance of the NBS RTGS system, clearing system, and interbank and international clearing of foreign exchange payments in September

In the course of 22 business days in September, a total of 19.3 million payments were processed in the NBS RTGS (15.6 million or 80.9%) and clearing systems (3.7 million or 19.1%). The average number of payments was 877,383 per day, of which 710,151 in RTGS and 167,232 in clearing.

The value of turnover in the RTGS system amounted to RSD 9,091.6 billion, while clearing turnover reached RSD 44.9 billion, or 0.5% of the total.

Daily turnover in the RTGS and clearing systems averaged RSD 413.3 billion and RSD 2.0 billion, respectively.

The downtime during 12,330 minutes of production of the NBS RTGS and clearing systems was 84 minutes and the system availability was 99.3%.
