**MONTHLY INFORMATION**  
**on the performance of the NBS RTGS system, clearing system, and interbank and international clearing of foreign exchange payments in September 2025**

During 22 business days in September 2025, a total of 18.9 million payments were processed in the NBS RTGS (18.1 million or 96.1%) and clearing systems (0.7 million or 3.9%). The average number of payments was 857,247 per day, of which 824,140 in RTGS and 33,107 in clearing.

The value of turnover in the RTGS system amounted to RSD 18,583.3 billion, while clearing turnover reached RSD 20.8 billion, or 0.1% of the total.

Daily turnover in the RTGS and clearing systems averaged RSD 844.7 billion and RSD 0.9 billion, respectively.

There was no downtime during 12,210 minutes of production of the NBS RTGS and clearing systems and the system availability was 100.0%.
