MONTHLY INFORMATION

on NBS RTGS and clearing system turnover and interbank and international clearing of foreign exchange payments in October 2015

In the course of 22 business days in October 2015, total 16.0 million payments were processed in the NBS RTGS (11.6 million or 72.5%) and clearing system (4.4 million or 27.5%). The average number of payments was 729,339 per day, of which 528,591 in RTGS and 200,748 in clearing.

The value of turnover in the RTGS system amounted to RSD 5,365.1 billion, while clearing turnover reached RSD 37.9 billion or 0.7% of the total.

Daily turnover in the RTGS and clearing system averaged RSD 243.9 billion and RSD 1.7 billion, respectively.

As there was no downtime during 12,240 minutes of production, the availability of the NBS RTGS and clearing system was 100%.
