MONTHLY INFORMATION

on the NBS RTGS and clearing system turnover and interbank and international clearing of foreign exchange payments in October

In the course of 22 business days in October, total 19.9 million payments were processed in the NBS RTGS (16.2 million or 81.4%) and clearing system (3.7 million or 18.6%). The average number of payments was 903,828 per day, of which 736,084 in RTGS and 167,744 in clearing.

The value of turnover in the RTGS system amounted to RSD 8,167.9 billion, while clearing turnover reached RSD 42.3 billion, or 0.5% of the total.

Daily turnover in the RTGS and clearing system averaged RSD 371.3 billion and RSD 1.9 billion respectively.

As there was no downtime during 12,330 minutes of production, the availability of the NBS RTGS and clearing system was 100%.
