MONTHLY INFORMATION

on the performance of the NBS RTGS system, clearing system, and interbank and international clearing of foreign exchange payments in October

In the course of 21 business days in October, a total of 19.2 million payments were processed in the NBS RTGS (15.5 million or 81.0%) and clearing systems (3.6 million or 19.0%). The average number of payments was 912,366 per day, of which 739,360 in RTGS and 173,006 in clearing.

The value of turnover in the RTGS system amounted to RSD 8,645.4 billion, while clearing turnover reached RSD 44.7 billion, or 0.5% of the total.

Daily turnover in the RTGS and clearing systems averaged RSD 411.7 billion and RSD 2.1 billion, respectively.

As there was no downtime during 11,715 minutes of production, the availability of the NBS RTGS and clearing systems was 100.0%.
