## MONTHLY INFORMATION

on the performance of the NBS RTGS system, clearing system, and interbank and international clearing of foreign exchange payments in November 2023

In the course of 22 business days in November 2023, a total of 19.2 million payments were processed in the NBS RTGS (17.7 million or 92.0%) and clearing systems (1.5 million or 8.0%). The average number of payments was 875,001 per day, of which 804,866 in RTGS and 70,135 in clearing.

The value of turnover in the RTGS system amounted to RSD 17,715.6 billion, while clearing turnover reached RSD 32.8 billion, or 0.2% of the total.

Daily turnover in the RTGS and clearing systems averaged RSD 805.3 billion and RSD 1.5 billion, respectively.

There was no downtime during 12,210 minutes of production of the NBS RTGS and clearing systems and the system availability was 100.0%.
