MONTHLY INFORMATION

on the performance of the NBS RTGS system, clearing system, and interbank and international clearing of foreign exchange payments in November 2025

In the course of 19 business days in November 2025, a total of 17.6 million payments were processed in the NBS RTGS (16.7 million or 94.4%) and clearing systems (1.0 million or 5.6%). The average number of payments was 928,103 per day, of which 876,612 in RTGS and 51,492 in clearing.

The value of turnover in the RTGS system amounted to RSD 16,269.4 billion, while clearing turnover reached RSD 23.9 billion, or 0.1% of the total.

Daily turnover in the RTGS and clearing systems averaged RSD 856.3 billion and RSD 1.3 billion, respectively.

There was no downtime during 10,575 minutes of production of the NBS RTGS and clearing systems and the system availability was 100.0%.
