MONTHLY INFORMATION

on the NBS RTGS system, clearing system, and interbank and international clearing of foreign exchange payments in December

In the course of 23 business days in December, a total of 22.3 million payments were processed in the NBS RTGS (18.3 million or 82.0%) and clearing systems (4.0 million or 18.0%). The average number of payments was 969,129 per day, of which 794,857 in RTGS and 174,272 in clearing.

The value of turnover in the RTGS system amounted to RSD 9,127.6 billion, while clearing turnover reached RSD 52.2 billion, or 0.6% of the total.

Daily turnover in the RTGS and clearing systems averaged RSD 396.9 billion and RSD 2.3 billion, respectively.

As there was no downtime during 12,765 minutes of production, the availability of the NBS RTGS and clearing systems was 100.0%.
