**MONTHLY INFORMATION**  
**on the performance of the NBS RTGS system, clearing system, and interbank and international**  
**clearing of foreign exchange payments in December 2025**

In the course of 23 business days in December 2025, a total of 21.1 million payments were processed in the NBS RTGS (19.9 million or 94.3%) and clearing systems (1.2 million or 5.7%). The average number of payments was 918,074 per day, of which 865,771 in RTGS and 52,304 in clearing.

The value of turnover in the RTGS system amounted to RSD 18,778.0 billion, while clearing turnover reached RSD 33.2 billion, or 0.2% of the total.

Daily turnover in the RTGS and clearing systems averaged RSD 816.4 billion and RSD 1.4 billion, respectively.

There was no downtime during 12,825 minutes of production of the NBS RTGS and clearing systems and the system availability was 100.0%.
