1. The National Bank of Serbia hereby assigns to banks the following fixed numbers (three digits) to be used as their unique identification numbers in the performance of dinar payment transactions:

2. The fixed unique account identification number of the REPUBLIC OF SERBIA (TREASURY ADMINISTRATION) shall be 840.

The fixed unique account identification number of the NATIONAL BANK OF SERBIA shall be 908.

- 3. Unique identification numbers specified herein shall be used when opening current accounts for the purposes of performing payment transactions in accordance with the Law on Payment Services and regulations adopted under that Law.
- 4. By way of exception to Section 1 hereof, where due to a status change data migration to a new core business application or to a different computer centre is carried out, within the meaning of the decision on minimum information system management standards for financial institutions the unique identification number previously used by a bank that ceased to exist due to the status change may be used temporarily by the bank that is its legal successor, in accordance with that decision.
- 5. This Decision repeals the Decision on the Assignment of Unique Identification Numbers for Payment Service Providers (G. No 7941 of 24 July 2023).
- 6. This Decision enters into force on the day of its publication on the website of the National Bank of Serbia.
