Subject: Additional information regarding bid preparation

On 18 September 2020 an interested party sent the following enquiry:

"Dear,

Thank you for your prompt reply.

As discussed by phone, we are going to be in trouble with the requested dates of documents listed in the LIST OF REQUIREMENTS SET DOWN IN ARTICLES 75 AND 76 OF THE LLP: as the information we got was about the BID to be opened in August, we have done the documents in advance (15 to 20 days are needed to complete the requested documents).

Now, if the BID opening date is the 5th of October, our documentation have expired and we need to make a new set, which means it may take up to the 12th of October to receive the documents and to make translations and authorizations, which means the opening date would be lost.

Is there any hope our documentation can be accepted as it is or is there any possible solution?
